- Going through archives to look at old plans and implement a new strategic plan around what worked in the past
- Want to review the process for HMGP Grants •
- 4. Seismic Safety
 - The meeting was postponed until December. The topic of the meeting is to work towards a resilient Washington State
- 5. Intrastate Mutual Aid Committee
 - The statute states that "the Committee is only authorized to develop and update guidelines and procedures to facilitate implementation of the intrastate mutual aid system by member jurisdictions"
 - The statute: "...a responding member jurisdiction shall designate in writing all assistance provided to a requesting member jurisdiction... consistent with the guidelines and procedures developed by the committee"
 - WAMAS members are counties, cities, towns, and tribes. The state is not a party to legislation • either. Operation manual is based on intra-state use
 - Products for Implementation: ٠
 - Deployment Guide (Done by EMD)
 - Operations Manual (Done by EMD)
 - Train the Trainer Materials (To be developed)
 - WAMAS Exercise Module (To be developed)
 - DOT has assigned public works and signed agreements with all 39 counties
 - Currently working on assigning the members for this committee the legislature only requires 4 members. Legislation states that the EMC chair will elect the members, but are not sure of the qualifications
 - Bring the original members together to discuss what they contributed to the process
 - The documents that have been written will be brought before the subcommittee to be approved before being presented to the EMC
 - Train EMD and military members to use this new tool •

EMC Action Requests

Recommend this group be a subcommittee to report to the EMC. There was also discussion of this group becoming part of the S.A.C.

- Currently working on a charter

State Preparedness Report

- FEMA add Tribal THIRA requirements for 2013 THSGP grant •
- FEMA announces Unified SPR/THIRA/NIMS Excel tool will be used from now on for data collection and submission; tool arrived late August

- FEMA updated THIRA guidance in late August, added Capability Estimation requirement for 13 Core Capabilities
- Combining rural and urban areas produced an average result
- The level of effort by region varies dramatically
- Changing our requirements from FEMA is not something we want to do every year. Can we divide the state into urban or rural areas, or can we divide the capabilities in other ways? How can we make this a better component for us? Rather than just putting a number in the block we need to better define our capabilities. It would mean more to the governor and TAG if they know what our capabilities really are.
- Use this report to update the governor
- The questions in the 2013 State Capabilities Assessment were anecdotal and in some cases beyond the ability of the respondent to answer. DSHS could not respond to questions outside the scope of its authority or that it could not support with evidence or otherwise measure.

MOTION: Endorse the State Preparedness Report (SPR) to serve as the annual report to be provided to the governor with the qualifiers:

- Inadequate time was available to prepare a comprehensive and consistent report.
- State agency input and local input not well-synchronized thereby skewing results.
- Lack of clarification of definitions and differentiation of roles between state agencies and local agencies.
- Work will be done in CY14 to improve both the process and therefore the quality and accuracy of the results.

The motion was seconded and approved.

Senior Advisory Committee

- EMD has extracted and coalesced the Grant Guidance into a concise format for easy reference (the S.A.C. Info Paper), identifying the "Who's, Must Do's, and Should Do's"
- Created an ad hoc S.A.C. Working Group (committee to form a committee) of volunteers to craft a proposed S.A.C.
- Reassessed the guidance and reviewed the original submission by Pierce County and concluded that there were very few "Must Do's" to be in compliance with the Grant Guidance
- Endorse plan to write and submit memo (via BSIR) showing compliance ... "EMC=S.A.C."
- Endorse plan for S.A.C. future development
 - Chartered S.A.C. Work Group with a plan for 2014
 - Proposed membership is still in the works

MOTION: Endorse the plan to write and submit memo (Via BSIR) showing compliance that the EMC = S.A.C.

Discussion:

> The size of the distribution list between the EMC and S.A.C. is getting rather large.

- The work group will be developing the ground rules. We need to do what's best for WA State, but not just count on the grants.
- > The larger the group the more unwieldy it gets.
- > EMD will *not* be adjusting SHSP and UASI governance and funding structures.
- Create the S.A.C. charter, identify membership and numbers, and develop a mission statement.

Following discussion, Ron MOTIONED "to support that the EMC does mean the S.A.C. and a letter be submitted", Dave seconded and all approved.

- The EMC is the S.A.C., and the work group is a committee that advises the EMC
